



INSTRUCTIONS FOR FOLLOW-UP PHONE QUESTIONNAIRE FORM FUQ, VERSION 5.0, QUESTION BY QUESTION (QxQ)

I. GENERAL INSTRUCTIONS

The Follow-up Phone Questionnaire Form is interviewer administered and completed during the follow-up phone conversations with study participants.

Header Information: The header information consists of key fields which uniquely identify each recorded instance of a form. For the Event field, record if this is happening at Visit 5 or another event.

0a. Date of Collection: Record the date the data was collected or abstracted. Select the date from the pop-up calendar in the data management system (DMS) or type the date in the space provided. Dates should be entered in the mm/dd/yyyy format.

0b. Staff Code: Record the SPIROMICS staff code of the person who collected or abstracted the data. This code is assigned to each person at each site by the GIC. If you do not have a staff code and are collecting SPIROMICS data, please contact the GIC in order to receive your own individual staff code.

II. DETAILED INSTRUCTIONS FOR EACH ITEM

Item 1. **Participant Status** Select only one option among the eight possible choices for how the subject's employment has changed since the last SPIROMICS visit.

- Select Contacted and alive if a member of the study staff was able to contact the participant and s/he is alive. [Go to Q2]
- Select Contacted and refused interview if a member of the study staff was able to contact the participant and s/he refused to be interviewed. [Go to 1d]
- Select Not contacted and reported alive if a member of the study staff was unable to contact the participant and s/he is reported to be alive. [Go to End]
- Select Not contacted and reported deceased if a member of the study staff was unable to contact the participant and s/he is reported to be deceased. [Go to 1a]
- Select Not contacted and left message if a member of the study staff was unable to contact the participant and left a message for the participant. [Go to End]
- Select Not contacted and unable to leave a message if a member of the study staff was unable to contact the participant and unable to leave a message for the participant. [Go to End]
- Select Not contacted, phone line disconnected if a member of the study staff was unable to contact the participant because the phone line is disconnected. [Go to End]
- Select Participant mailed in form if a member of the study staff is hard of hearing finding it difficult to hear coordinator administer the questionnaire via phone and form is mailed back to site. [Go to Q2]

Item 1a. **Date of Death** Record the date the participant died. Select the date from the pop-up calendar in the data management system (DMS) or type the date in the space provided. Dates should be entered in the mm/dd/yyyy format.

Item 1b. **City, state, and country death occurred** Record the city, state, and country where the death occurred in the space provided.

Item 1c. **Known hospitalization or emergency room visit** Select only one option among the two possible choices.

- Select No if the phone respondent did not know if the participant was hospitalized or visited an emergency room for any reason between the date of last contact and his/her death. [Go to End]
- Select Yes if the phone respondent did know if the participant was hospitalized or visited an emergency room for any reason between the date of last contact and his/her death. [Go to Q20a]

Note: Question 1d has been removed.

Item 1d1. **Participant willing to be contacted** Select only one option among the two possible choices.

- Select No if the participant is not willing to be contacted regarding future in-person clinic visits. [Complete the RSW form]
- Select Yes, willing to be contacted if the participant is willing to be contacted regarding future in-person clinic visits.

NOTE: The next four fields will automatically populate in the DMS.

Item 1e. **Consented for SPIROMICS II** CDART will automatically populate the date the participant was consented for SPIROMICS II based on the value entered in the ITF form (i.e., ITF0a). *If ITF0a is missing or not entered appropriately, Item 1e will not populate and will remain a greyed-out box.*

Item 1e1. **Five years since SPIROMICS II consent** CDART will automatically populate the field with Yes or No based on the date populated in 1e and the current date (the date the form is opened). *If Item 1e (ITF0a) is missing or not entered appropriately, Item 1e1 will not populate and will remain a greyed-out box.*

Item 1e2. **Quarterly follow-up phone call extension** CDART will automatically populate the field with Yes or No based on FUQ data entry. If Item 1e2 is populated with No, the participant has not yet consented to the quarterly follow-up phone call extension [Go to Q1f]. *If the FUQ is missing or not entered appropriately, Item 1e2 will not populate and will remain a greyed-out box.*

Item 1e2a. **Date of follow up consent** CDART will automatically populate the FUQ period the participant was consented for the quarterly follow-up phone call extension based on data entered in the FUQ form. *If the FUQ is missing or not entered appropriately, Item 1e2a will not populate and will remain a greyed-out box.*

Item 1f. **Continue follow-up phone calls** Select only one option among the two possible choices.

- Select Yes, willing to be contacted for additional quarterly follow-up if the participant wishes to continue quarterly follow-up phone calls. [Go to Q2]
- Select Yes, not willing to be contacted for additional quarterly follow-up if the participant does not wish to continue quarterly follow-up phone calls. [Go to End] *The interviewer should discuss with the participant which studies/activities they want to be involved in. Complete the RSW after this form has been Saved and Closed.*
- Select No, awaiting local IRB approval for the extension memo if your site has not yet received local IRB approval. *Only move forward with the phone call if it has not been five years since the participant's SPIROMICS II consent date.*

HOSPITALIZATIONS

- Item 2. **Flare-up of chest trouble** Select only one option among the two possible choices.
- Select No if the subject reports not having a flare-up of chest trouble since his/her last clinic visit or telephone contact. [Go to 20]
 - Select Yes if the subject reports having a flare-up of chest trouble since his/her last clinic visit or telephone contact.

Item 2a. **Number of flare ups** Record how many episodes of chest trouble flare-ups the subject reported having since his/her last clinic visit or telephone contact.

First Flare-up:

- Item 3a. **Took additional antibiotics** Select only one option among the two possible choices.
- Select No if the subject reports not taking additional antibiotics after contacting his/her healthcare provider by telephone or email.
 - Select Yes if the subject reports taking additional antibiotics after contacting his/her healthcare provider by telephone or email.

- Item 3b. **Took additional oral steroids** Select only one option among the two possible choices.
- Select No if the subject reports not taking additional oral steroids after contacting his/her healthcare provider by telephone or email.
 - Select Yes if the subject reports taking additional oral steroids after contacting his/her healthcare provider by telephone or email.

- Item 3c. **Took additional antibiotics without contacting provider** Select only one option among the two possible choices.
- Select No if the subject reports not taking additional antibiotics without contacting his/her healthcare provider by telephone or email.
 - Select Yes if the subject reports taking additional antibiotics without contacting his/her healthcare provider by telephone or email.

- Item 3d. **Took additional oral steroids** Select only one option among the two possible choices.
- Select No if the subject reports not taking additional oral steroids without contacting his/her healthcare provider by telephone or email.
 - Select Yes if the subject reports taking additional oral steroids without contacting his/her healthcare provider by telephone or email.

- Item 3e. **Physician's office or urgent care evaluation** Select only one option among the two possible choices.
- Select No if the subject reports not being evaluated in a physician's office or urgent care.
 - Select Yes if the subject reports being evaluated in a physician's office or urgent care.

Items 3e1-4. **Physician's office or urgent care evaluation actions** Select all the options among the four possible choices based on what the subject reports regarding his/her visit to a physician's office or urgent care.

- Item 3f. **Emergency department evaluation** Select only one option among the two possible choices.
- Select No if the subject reports not being evaluated in an emergency department.
 - Select Yes if the subject reports being evaluated in an emergency department.

Items 3f1-4. **Emergency department evaluation actions** Select all the options among the four possible choices based on what the subject reports regarding his/her visit to an emergency department.

- Item 3g. **Hospital admission** Select only one option among the two possible choices.
- Select No if the subject reports not being admitted to a hospital. [If a second episode occurred, go to 6. Otherwise, go to 20]
 - Select Yes if the subject reports being admitted to a hospital.
- Item 4a. **Date of Hospitalization** Record the date the participant was hospitalized. Select the date from the pop-up calendar in the data management system (DMS) or type the date in the space provided. Dates should be entered in the mm/dd/yyyy format.
- Item 4b. **Name of medical facility** Record the name of the medical facility where the participant was hospitalized in the space provided.
- Item 4c. **Address of medical facility** Record the address of the medical facility where the participant was hospitalized in the space provided.
- Item 4d1. **First name on patient record** Record the first name used for the hospital record for this visit in the space provided.
- Item 4d2. **Second name on patient record** Record the second name used for the hospital record for this visit in the space provided.
- Item 4d3. **Last name on patient record** Record the last name used for the hospital record for this visit in the space provided.
- Item 4d4. **Maternal last name on patient record** Record the maternal last name used for the hospital record for this visit in the space provided.
- Item 4e. **Time in ICU** Select only one option among the two possible choices.
- Select No if the subject reports not having spent any time in in the intensive care unit (ICU).
 - Select Yes if the subject reports being having spent any time in in the intensive care unit (ICU).
- Item 4f. **Intubation** Select only one option among the two possible choices.
- Select No if the subject reports not having been intubated or placed on a breathing machine or ventilator through a tube in his/her mouth or nose.
 - Select Yes if the subject reports being having been intubated or placed on a breathing machine or ventilator through a tube in his/her mouth or nose.

Note: Question 5 has been removed.

- Item 6a. **Took additional antibiotics** Select only one option among the two possible choices.
- Select No if the subject reports not taking additional antibiotics after contacting his/her healthcare provider by telephone or email.
 - Select Yes if the subject reports taking additional antibiotics after contacting his/her healthcare provider by telephone or email.
- Item 6b. **Took additional oral steroids** Select only one option among the two possible choices.
- Select No if the subject reports not taking additional oral steroids after contacting his/her healthcare provider by telephone or email.
 - Select Yes if the subject reports taking additional oral steroids after contacting his/her healthcare provider by telephone or email.

Item 6c. **Took additional antibiotics without contacting provider** Select only one option among the two possible choices.

- Select No if the subject reports not taking additional antibiotics without contacting his/her healthcare provider by telephone or email.
- Select Yes if the subject reports taking additional antibiotics without contacting his/her healthcare provider by telephone or email.

Item 6d. **Took additional oral steroids** Select only one option among the two possible choices.

Item 6e. **Physician's office or urgent care evaluation** Select only one option among the two possible choices.

Items 6e1-4. **Physician's office or urgent care evaluation actions** Select all the options among the four possible choices based on what the subject reports regarding his/her visit to a physician's office or urgent care.

Item 6f. **Emergency department evaluation** Select only one option among the two possible choices.

- Select No if the subject reports not being evaluated in an emergency department.
- Select Yes if the subject reports being evaluated in an emergency department.

Items 6f1-4. **Emergency department evaluation actions** Select all the options among the four possible choices based on what the subject reports regarding his/her visit to an emergency department.

Item 6g. **Hospital admission** Select only one option among the two possible choices.

- Select No if the subject reports not being admitted to a hospital. [If a third episode occurred, go to 9. Otherwise, go to 20]
- Select Yes if the subject reports being admitted to a hospital.

Item 7a. **Date of Hospitalization** Record the date the participant was hospitalized. Select the date from the pop-up calendar in the data management system (DMS) or type the date in the space provided. Dates should be entered in the mm/dd/yyyy format.

Item 7b. **Name of medical facility** Record the name of the medical facility where the participant was hospitalized in the space provided.

Item 7c. **Address of medical facility** Record the address of the medical facility where the participant was hospitalized in the space provided.

Item 7d1. **First name on patient record** Record the first name used for the hospital record for this visit in the space provided.

Item 7d2. **Second name on patient record** Record the second name used for the hospital record for this visit in the space provided.

Item 7d3. **Last name on patient record** Record the last name used for the hospital record for this visit in the space provided.

Item 7d4. **Maternal last name on patient record** Record the maternal last name used for the hospital record for this visit in the space provided.

Item 7e. **Time in ICU** Select only one option among the two possible choices.

- Select No if the subject reports not having spent any time in in the intensive care unit (ICU).
- Select Yes if the subject reports being having spent any time in in the intensive care unit (ICU).

Item 7f. **Intubation** Select only one option among the two possible choices.

- Select No if the subject reports not having been intubated or placed on a breathing machine or ventilator through a tube in his/her mouth or nose.
- Select Yes if the subject reports being having been intubated or placed on a breathing machine or ventilator through a tube in his/her mouth or nose.

Note: Question 8 has been removed.
